County Auditor, Noe Gamez read the letter Pursuant to Local Government Code 111.0108 to certify that Jim Wells County received \$87,813.44 by ACH deposit on 05-09-2017. The monies are for expenditures and a request of budget amendments to the 2017 Jim Wells County Budget. Emergency Management Coordinator, Lynn Kirchoff suggested to move forward as per the committee working together with the City of Alice, City of Orange Grove, Ben Bolt, and Sandia and Jim Wells County with funding of over \$49,000.00 for equipment.
