## RESOLUTION 2025-0716

A RESOLUTION OF THE COUNTY OF JIM WELLS, TEXAS, AUTHORIZING THE SUBMISSION OF A CONTRACT AMENDMENT REQUEST FOR TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (TxCDBG) CONTRACT NUMBER CFC22-0144 BETWEEN THE COUNTY AND THE TEXAS DEPARTMENT OF AGRICULTURE.

WHEREAS, Jim Wells County entered into a Texas CDBG contract with the Texas Department of Agriculture to put in new water lines and first-time connections for households in Coyote Acers and McMasters colonias.

WHEREAS, during the course of the project engineering and construction, changes to the original project scope were deemed necessary due to a decrease in the number of households participating in the first-time connection opportunity.

WHEREAS, the changes provide similar benefits and affect the same part of Jim Wells County, namely the installation of new water lines and first-time water connections.

WHEREAS, Jim Wells County will hold a hearing open to members of the public to discuss the proposed changes and consider all comments received in making this decision; and

WHEREAS, Jim Wells County desires to amend its contract to reflect these changes for the general improvement of water service in the area.

NOW, THEREFORE, BE IT RESOLVED:

1. The Commissioner's Court authorizes a contract amendment request to be submitted to the Texas Department of Agriculture for the modifications to its Texas CDBG Contract CFC22-0144 Performance Statement described in Attachment A, attached hereto and incorporated herein.
2. The Commissioner's Court directs and authorizes the County Judge to execute all necessary documents as may be required to initiate and process this contract amendment request.
